#### COMPATIBILITY AND INTENDED USE

MSW bottle cages are compatible with traditional two-bolt fit and placement on most bicycles.

#### TOOLS REQUIRED

4mm hex wrench or hex wrench appropriate for the bolts used

Grease

Torque wrench that measures in Nm

#### INSTALLING THE MSW BOTTLE CAGE

- 1. Remove bolts that are already on the bike.
- 2. Grease the threads of the bolts before reinstalling.
- 3. Place the bottle cage over the bolt holes.
- 4. Reinstall the bolts and tighten to 4Nm.

**WARNING:** Where you position the cage will depend on personal preference, frame size and geometry. Make sure the cage does not interfere with the function of your bicycle **BEFORE** attempting to ride.

## **ONGOING MAINTENANCE**

Periodically check to make sure the attachment bolts are tightened to 4Nm.
